**ORDER**

As per the G.O. read 1st above, Government introduced Electronic Ledger Account Monitoring System (e-LAMS) to prevent hasty and imprudent expenditure at the fag end of the financial year. Thereafter detailed operational guidelines were also issued for the release and utilisation of the amount posted in e-LAMS vide G.O. read 2<sup>nd</sup> and 4<sup>th</sup> above. As per GO read 4<sup>th</sup> and 5<sup>th</sup> above time limit for release of amount posted in e LAMS during the last financial year (2018-19) is limited up to 30<sup>th</sup> September 2019 and was extended up to 31/10/2019, subsequently.

Government are now pleased to extend the scheme for the current financial year (2019-2020) also. All the guidelines issued so far will be applied during this year also. Apart from the above, the following additional guidelines are issued for strict compliance by all concerned.

- i. Under no circumstance the amount posted in the e-LAMS will be released after 30<sup>th</sup> September of the subsequent financial year.
- ii. All proposals requiring the posting of the amount under e-LAMS shall be submitted to the Finance Department well in advance, before 28/03/2020.
- iii. The resumption proposal, including the fund required under e-LAMS shall be submitted on or before 31/03/2020.
