## **CIRCULAR**

No. 43/2021/Fin

Dated, Thiruvananthapuram, 17/05/2021

Sub: Budget Allocation and Monitoring System (BAMS) - Guidelines for declaration of Chief Controlling Officer/ Subordinate Controlling Officer of a head of account and cross-mapping of heads of account in BAMS - issued.

The system of distribution of budgetary appropriations and enforcement of control over expenditure are managed through the hierarchy consisting of the Chief Controlling Officer (CCO), the Subordinate Controlling Officers (SCO) and the Drawing and Disbursing Officers (DDO), as stipulated in Para 62 (1) and 69 of the Kerala Budget Manual. The Departments are at present, exercising the responsibilities of budget distribution and enforcement of expenditure control through this three tier architecture (CCO-SCO-DDO) in the Budget Allocation and Monitoring System (BAMS) which has been introduced for the automated processing of fund allotment. BAMS is also facilitating inter Department/CCO fund allotment through the option of cross-mapping of heads of account from a CCO to an SCO of another CCO or from an SCO to a DDO under an SCO of another CCO.

- 2. As part of ensuring standard procedures to be observed in BAMS, the following guidelines are issued for the declaration of Chief Controlling Officer and Sub Controlling Officer of a head of account, mapping, etc:-
  - (i) The Administrative Departments shall forward proposals to the Finance Department for declaring an officer as a CCO/SCO, declaring CCO for a new head of account, changing the CCO of an existing head of account or modifying the designation of the CCO/SCO in BAMS.
  - (ii) Such proposals shall contain the details such as designation of the CCO/SCO, Name of Department and Office, head of account, etc.
  - (iii) Necessary orders will be issued by the Finance (Budget Wing) Department on the basis of such proposals from the Administrative Departments for declaring a new CCO/SCO or changing an existing CCO of a head of account.
  - (iv) Pursuant to issuing the above orders, mapping of the relevant head of account to the Controlling Officer concerned in BAMS will also be done by the Finance (Budget Wing) Department.
  - (v) The entry of the details of a new CCO/SCO in BAMS will be done by the Director of Treasuries on the basis of the orders issued by the Finance (Budget Wing) Department.
  - (vi) The mapping of heads of account to the Sub Controlling Officers/DDO in BAMS will respectively be done by the Controlling/Sub Controlling Officers. Separate

- order/approval from Government is not required for mapping a head of account by the CCO/SCO to their lower level in BAMS.
- (vii) The addition, modification, deletion of any records pertaining to Controlling Officers/Sub Controlling Officers/DDO in BAMS will be done only on the basis of specific orders/instructions issued by the Finance (Budget Wing/Streamlining) Department to the Treasuries Department or the National Informatics Centre (NIC), as the case may be.
- 3. The flow of allotment of funds in BAMS is designed for the distribution of funds from CCO to SCO or from SCO to DDO of the same CCO. BAMS also permits inter-CCO allotment through the option of 'cross-mapping'. The following guidelines are issued for cross-mapping of heads of account for inter-CCO fund allotment in BAMS:-
  - (i) If allotment of funds to the SCO/DDO under a different CCO becomes inevitable for the implementation of schemes/ projects and to avoid unnecessary parking of Government money in treasury / bank accounts, CCO/SCO of the head of account from which allotment needs to be given to an implementing department can allocate necessary funds through BAMS by cross-mapping heads of account to SCO/DDO of the implementing departments. Based on allotments, the DDO of the implementing departments can prepare required bills in Bill Information & Management System (BiMS) for withdrawal of funds directly from the head of account for making payment to end beneficiary. For facilitating such allotment through the option of crossmapping in BAMS, the CCO of the head of account shall submit proposal directly to Finance Department for necessary sanction.
  - (ii) Such proposals shall contain the details such as designation of the existing CCO, Name of the Department, head of account and the Designation of the CCO and Name of the Department to which the cross-mapping is required.
  - (iii) The Finance (Budget Wing) Department will issue orders of sanction for cross-mapping after examining the necessity and admissibility.
  - (iv) Based on the sanction from Finance Department, the Controlling Officer shall submit cross-mapping request to the treasury concerned, with the details including codes assigned in BAMS to the SCO/DDO to be cross-mapped, whereon, the treasury shall execute the cross-mapping in BAMS. The orders of sanction by the Finance Department for cross mapping shall clearly specify the CCO of the head of account and the CCO of the SCOs/DDOs to be cross-mapped. Separate approval/order from Government is not necessary for cross-mapping a new/existing SCO/DDO of that CCO to the head of account if such a requirement arises later.

- (v) Ensuring the proper reconciliation of accounts in respect of a head of account which is cross-mapped to the SCO/DDO of another CCO, shall be the responsibility of the original CCO of that head of account.
- (vi) The cross-mapped SCOs/DDOs are responsible for all the statutory obligations in respect of the cross-mapped head of account, such as maintenance of accounts, reconciliation and reporting as laid down in Kerala Budget Manual, Kerala Financial Code and Kerala Treasury Code and they shall report the details of utilization of fund allotted from the cross-mapped head of account to the original CCO of the head of account.
- 4. If necessary, the existing designated SCO/DDO under the original CCO may continue to operate a head of account even when the head is cross-mapped to an SCO/DDO under another CCO. Separate orders/approval from Government is not required in this case.
- 5. The existing practice of the Administrative Department forwarding proposals to the Finance Department for declaring a new DDO shall continue without any change
- 6. The Director of Treasuries shall make necessary arrangements and designate officers in the Treasuries Department for facilitating the smooth execution of cross-mapping in BAMS as stated above. He shall give necessary instructions to all the Treasury Officers and provide them with the contact details of the designated officers to ensure timely processing of cross-mapping requests received at the treasuries and proper liaison between the user departments and the Treasury Department BAMS Team.
- 7. The list of heads of accounts which are cross-mapped to other SCOs/DDOs is attached as Annexure-1 for reference.
