**ORDER**

Director of Treasuries vide his letter read 1<sup>st</sup> above has submitted proposal to enhance the present delegation of powers of treasury officers for the purchase of Computer cosumables and also to delegate the financial powers sanctioned in the case of District Treasury Officer to the Deputy Directors and Assistant Directors in the case of their respective offices and the delegation of financial powers in the case of Sub Treasury Officers to Stamp Depot Officers.

2) Government, after examining the matter in detail are pleased to enhance the existing limits of financial powers delegated to District Treasury Officers and Sub Treasury Officers as detailed below.

3) It is further ordered to delegate the financial power sanctioned in the case of District Treasury officers to Deputy Directors & Assistant Directors also, to their respective offices. And the financial power of the Sub Treasury Officers is extended to Stamp Depot Officers. This is for the administrative convenience and smooth functioning of Treasury department.
