ORDER

Government are pleased to order that the rates of Dearness Allowance sanctioned in the G. O. read as second paper above will be revised with effect from First May, 1980, as shown in the Annexure.

2. In the case of those who remain in the pre-revision (1978) scale of pay, the amount of Dearness Allowance will be calculated as already ordered in the G. O. read as first paper above, the rates of Dearness Allowance admissible for increase in the cost of living index beyond 272 points, being replaced by the rates specified in the Annexure to this order.

3. These orders will apply to the full time State Government employees, staff of Aided Schools, Private Colleges and Polytechnics, full time employees borne on contingency and work charged establishments and employees of local bodies, subject to the condition that the expenditure on this account in respect of local bodies, will be met from the funds of the respective local bodies.
