ORDER

Government are pleased to order that the rates of D. A. sanctioned in the Government order read as third paper above will be revised with effect from 1st June 1982 as shown in the Annexure. The payment in respect of this instalment of D. A. will be in cash from 1-4-1983. The payment for the period from 1-6-1982 to 31-3-1983 will be made to the Provident Fund accounts of the employees in the manner indicated in para 4 below.

2. In the case of those who remain in the pre-revision (1978) scales of pay, the amount of Dearness Allowance will be calculated as already ordered in the Government Order read as second paper above, the rates of Dearness Allowance admissible for increase in the cost of living index beyond 272 points being replaced by the rates specified in the Annexure to this order.

3. These orders will apply to full-time State Government employees, staff of Aided Schools, Private Colleges and Polytechnics, full-time employees borne on contingency and work-charged establishments and employees of local bodies, subject to the condition that the expenditure on this account in respect of local bodies, will be met from the funds of the respective local bodies.

4. (a) The arrears on account of the D. A. now sanctioned—vide para 1 above and Annexure—accruing up to 31-3-1983 shall be deposited in the Provident Fund accounts of the employees.

(b) Arrear bills for the gross amount of the arrears of D. A. up to 31-3-1983 shall be prepared and presented to the concerned treasuries for 'NIL' (net) amount, the amount being transfer credited to the Provident Fund accounts of the employees. Bills will be supported by G. P. F. schedules according to the normal requirements. It should be clearly noted in the schedules that the deduction represents arrears of D. A. up to 31-3-1983. The adjustment bills as above should be presented at the treasuries, before claiming the D. A. payable in cash from 1-4-1983.

(c) The normal rules relating to the drawal of advances from Provident Funds will apply in the case of the D. A. arrears up to 31-3-1983 now ordered to be credited to the Provident Fund account of the employees.

(d) The above procedure will be applicable *mutatis mutandis* to Provident Funds other than General Provident Fund also. In regard to Contributory Provident Fund, however, there will be no matching contribution from the Government in respect of the arrears of D. A.

5. The rates of Dearness Allowance of Part-time Teachers and Part-time employees sanctioned in the Government Order read as third paper above will also be revised as follows:—

The above categories will be allowed the entire amount due from 1-6-1982 in cash and the orders contained in para 4 above will not apply in their case.

6. The "one time increase" in D. A. sanctioned to the officers will continue to be paid as per the G. O. read as fourth paper above.
