ORDER

Government are pleased to order that over and above the D. A. increases sanctioned in the Government Order read above, the State Government Officers in the pay range of Rs. 1,762 to Rs. 2,750 will be allowed as *one time measure* on a regular basis, with effect from 1-9-1982, ad hoc D. A. at 54% of their basic pay at 200 points, minus Rs. 820 subject to a maximum of Rs. 345 p. m. as shown in the Annexure. The payment in respect of the ad hoc D. A. will be made *in cash* from 1-4-1983 and the payment for the period from 1-9-1982 to 31-3-1983 will be made to the Provident Fund Accounts of the officers, in the manner detailed in para 3 below.

2. The ad hoc D. A. increase as above will be admissible *only on the basic pay* of the officers concerned, without including Special Pay, Deputation Special Pay, Special allowance or any addition to pay under any other nomenclature.

3. (i) The arrears on account of the ad hoc D. A. now sanctioned—vide para 1 above—accruing up to 31-3-1983 shall be deposited in the Provident Fund Accounts of the officers concerned.

(ii) Arrear bills for the gross amount of the arrears of ad hoc D. A. up to 31-3-1983 shall be prepared and presented to the concerned treasuries for NIL (Net) amount, the amount being transfer credited to the

Provident Fund Accounts of the officers. Bills will be supported by G. P. F. schedules according to the normal requirements. It shall be clearly noted in the schedules that the deduction represents arrears of ad hoc D. A. due up to 31-3-1983. The officers concerned should present the adjustment bills as above, before claiming the ad hoc D. A. payable in cash from 1-4-1983.

(iii) The normal rules relating to the drawal of advances from Provident Fund will apply in the case of the arrears of ad hoc D. A. up to 31-3-1983, ordered to be credited to the Provident Fund Accounts of the officers.

(iv) The above procedure will be applicable *mutatis mutandis* to Provident Funds other than General Provident Fund also.
