ORDER

As per the Government Order read as 2nd above, the post of Personal Assistant attached to the offices of the Government Secretaries was redesignated as Personal Secretary on condition that the redesignation of post will not involve a change in duties and responsibilities and that it will not entitle the officers to any additional monetary benefits. As per Government Order read as 1st above, orders have been issued revising pay and allowances of State Government Employees and Teachers with effect from 01.07.2014 and ordered, inter alia, that out of the total posts of Personal Assistant (HG), four posts will be upgraded as Personal Secretary in the scale of pay of Rs. 45800-89000 and it is specified that three of these posts will be attached to the Offices of the Chief Secretary/Additional Chief Secretaries in General Administration Department and another one in the Office of the Additional Chief Secretary, Finance Department.

2.In view of the higher scale of pay ordered to the post of Personal Secretary vide G.O. 1st above some stipulations in the GO read as 2nd above have become infructuous. Therefore Government are now pleased to issue the following clarifications:

(1)No posts of Personal Secretary other than that ordered in G.O. 1st will exist in Government Secretariat w.e.f 01.02.2016.

(2) The higher scale of pay admissible to the post of Personal Secretary will have effect from 1/2/2016.

(3) Change of duties will not be involved on redesignation and assigning higher scale of pay to the post of Personal Secretary.

(4). The number of posts of Personal Secretary will be taken into the credit of Personal Assistant (HG) for fixing ratio between Personal Assistant and Personal Assistant(HG).

(5) Appointment to the newly designated post of Personal Secretary will be made from Personal Assistant(HG) on the basis of seniority.

(6) Fixation of pay under appropriate rules in KSR will be admissible on promotion from Personal Assistant (HG) to Personal Secretary and the persons so promoted will be eligible for leave salary/pay and allowances of the higher post in the event of vacating posts on account of leave or deputation. Such vacancies will be filled up as per the usual procedure.

3. It will take effect from 01.02.2016
