ORDER

In connection with the implementation of PFMS in the State, Government of India has setup a State Project Monitoring Unit (SPMU) for the State. Office of Controller General of Accounts (CGA) has requested to provide 4300 Square feet office space to SPMU vide letter read as 1st paper above. Due to space constraints in the office space now provided to SPMU of PFMS in the Centre for Training in Financial Management (CTFM) building at Kerala University Campus, they are not able to conduct training programmes and discussions with various departments smoothly.

In the IFMS review meeting held on 18.01.2017, Additional Chief Secretary(Fin) has decided to shift SPARK PMU to DPC building at Kerala University Campus and to allot office space of SPARK PMU now available in the Spark rented building of Kerala State IT Mission(KSITM) to SPMU of PFMS, who are facing space constraints. Accordingly, Director, KSITM has agreed to allot the office space now available in the Spark building of KSITM, at Uppalam road to SPMU of PFMS on reimbursement of rent, telephone, electricity, water charges etc. and intimated that rent for the floor proposed to be allotted to SPMU is Rs.71,137/- per month vide letter 4th cited.

Government having examined the matter are pleased to allot the office space occupied by SPARK PMU in the Spark rented building of KSITM, at Uppalam road to SPMU of PFMS for the implementation of PFMS in the State for a period up to 31.03.2018. The monthly rent of Rs.71,137/- and telephone, electricity and water charges will be reimbursed to KSITM.

The expenditure on account of rent, telephone, electricity and water charge etc. of SPMU office will be debited from the head of account "2052-00-090-96-FD-06-RRT(NP)".
