ORDER

As per the G.O read as 1st paper above, Government had constituted a mechanism entitled GoK CII Consultative Forum with the mandate to address the various issues of concern relating to industry, trade and investment and to act as a catalyst for promotion of investment climate, industrial growth, skill and entrepreneurship development and infrastructure development in the State through consultation, networking and establishing linkages between various stake-holders in Government and industry. Now, it has been decided to include industry engagement with specially abled people, ease of doing business, skill gap study and focus on defence electronics apart from district level activities in the mandate of the Forum based on the request of Confederation of Indian Industry (Southern Region) as per note read as 2nd paper above.

2. Government after having examined the matter and are pleased to reconstitute a mechanism entitled 'GoK CII Consultative Forum' with the mandate to address the various issues of concern relating to industry, trade and investment and to act as a catalyst for promotion of investment climate, industrial growth, skill and entrepreneurship development and infrastructure development in the state and other activities, apart from district level, viz; industry engagement with specially abled people, ease of doing business, skill gap study and focus on defence electronics through consultation, networking and establishing linkages between various stakeholders in Government and industry.

3. The Forum will be chaired by the Chief Secretary to Government with Additional Chief Secretary (Finance) and Principal Secretary (Industries) as Vice-chairs and will comprise as its members Secretary to Chief Minister, Principal Secretary (Public Works), Principal Secretary (Power & Ports), Secretary (Information Technology), Secretary (Planning & Economic Affairs), Principal Secretary (Taxes), Principal Secretary (Local Self Government), Secretary (Tourism), Managing Director, KSIDC, Managing Director KINFRA, Managing Director INKEL, Managing Director KFC and Convenor SLBC and Vice Chairman CII, Kerala State Council, two former Chairmen of CII Kerala State

Council, Chairman CII Thiruvananthapuram Zone, Chairman CII Thrissur, Chairman CII Palghat, Chairman CII Kottayam, Regional Director CII Southern Region, Director and Head CII, Kerala State Office, the Chairperson of the Forum may co-opt any other member in case required.

4. The State Chairman of CII Kerala will be its Convenor. The Forum will meet once in three months. The CII Kerala office will act as its Secretariat. The nodal point in Government to deal with matter relating to the Forum will be Finance (Planning) Department. It is expected that this mechanism will prove useful and help realize the full potential of trade, industry and investment that exists in the State and thereby enhance the States' GSDP and accelerate the industrial and infrastructure development in the state.
