ORDER

Government of India in its letter read above have released an amount of **Rs. 5,25,00,000/-** (Rupees Five Crore and Twenty five Lakhs Only) to the State Government of Kerala as 2nd instalment of central assistance for 2016-17 for the implementation of IWMP projects under watershed component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during 2016-17. It is directed to transfer this fund with corresponding state share. The funding pattern under Watershed Development Component of PMKSY is 60:40 between Centre and the States.

2. Government after having examined the matter in detail, are pleased to authorise the Commissioner, Rural Development Department to release an amount of **Rs. 8,75,00,000/-** (Rupees Eight Crore and Seventy five Lakhs Only) to the Project Directors of IWMP, Kerala being 2nd instalment of Central & State share (General) for the implementation of IWMP projects under Watershed Component of PMKSY for the year 2016-17 as detailed below:
