ORDER

Government of India, as per letter read above, have released an amount of **Rs. 48,57,000/-** (Rupees Forty eight Lakhs Fifty seven Thousand only) to the State Government as Grant-in-aid under TSP to the State Government of Kerala as second instalment of Central share for the implementation of projects under NRLM during 2016-17. It is also directed to transfer this fund along with state share. The funding pattern is 60:40 between Centre and the State.

2.Government after having examined the matter in detail, are pleased to authorise the Commissioner, Rural Development Department to release an amount of **Rs. 80,95,000/-**(Rupees Eighty Lakh and Ninety five Thousand Only) to the Executive Director, Kudumbasree, Kerala being the 2nd instalment of Central and State share under NRLM/Aajeevika for the year 2016-17 as detailed below:-
