ORDER

The existing rates of Compensatory Allowance specified under the Note Below Class VI of Appendix VI, Kerala Service Rules admissible to different classes of officers deputed for training outside the State for a period exceeding three months will be revised as follows:

Category of Officers	Rates for Cities of New Delhi, Mumbai, Culcutta (Rupees per month)	Rate for other places (Rupees per month)
1	2	3
Officers of Grade I (all officers who draw an actual basic pay of Rs. 50400/- and above)	1575	1315
Grade II(a) (officers with actual basic pay of Rs. 42500 and above, but below Rs.50400/-)	1400	1140
Grade II (b) (officers with actual basic pay of Rs. 27800 and above, but below Rs. 42500)	1140	920
Grade III (officers with actual basic pay of Rs.18000 and above, but below Rs.27800)	1010	745
Grade IV (officers with actual basic pay below Rs.18000)	920	615

2. The revised rates will come into force with effect from the date of the order.
