**ORDER**

As per the G.O read above, Government have accorded sanction for opening non-interest bearing Special TSB accounts in the designation of 10 Special Tahsildars / Tahsildars with respective treasuries for transaction of fund received in connection with the LA works. The District Collector has also requested sanction to open a non-interest bearing Special TSB account in the designation of the Special Tahsildar (LA) MVIP, Koothattukulam with Sub Treasury, Koothattukulam for transaction of fund received in connection with the LA works.
