### ORDER

–

Government in its order read as 3<sup>rd</sup> paper above have bifurcated the Thaliparamba Municipality as Thaliparamba and Anthoor Municipality. The Bifurcation required transfer of projects and financial resources and the same has been done based on the population available at that time and the same arrangement is continuing as such.

The Chairperson, Anthoor Municipality in the letter read as 5<sup>th</sup> paper above has reported that majority of the SCP projects approved by DPC and started in the Thaliparamba Municipality in 2015-16 has been transferred to Anthoor Municipality because of the location advantage. But the allocation of funds was made purely based on population. Therefore the SCP component authorised was not matching with the fund requirement for SCP projects transferred to Anthoor Municipality.

Government in its order read as 4<sup>th</sup> paper above have instructed that those projects which have approved by the DPC and have started before 31<sup>st</sup> March 2016 and completed during this

financial year, the expenditure can be met from the current year budget provision. In case any deficiency in funds that would be made up.

The Chairperson, Anthoor Municipality in the letter read as 5<sup>th</sup> paper above has reported that they have completely spent their current year budget provision under SCP and have pending bills amounting to Rs. 39.00 lakh relating to the Spill over projects under SCP. It is also reported that they have an unspent balance of Rs. 10 lakh as on 31/03/2016. It is also ascertained from the Thaliparamba Municipality that they have an unspent balance of Rs. 29.00 lakh as on 31/03/2016, which would have been spent for these projects but for the bifurcation of the Thaliparamba Municipality and creation of Anthoor Municipality.

Government have examined the matter in detail and are pleased to authorize Rs. 39. 00 lakh (Rupees Thirty Nine lakh only) (clubbing of Rs. 10 lakh unspent balance available as on 31/03/2016 in the Anthoor Municipality and Rs. 29.00 lakh unspent balance available as on 31/03/2016 in the Thaliparamba Municipality) under SCP as additional authorisation subject to the following conditions.

- i. Anthoor Municipality shall ensure the provisions of the Government order read as 4<sup>th</sup> paper above
- ii. The authorization of funds is under the head of account 3604-00-200-86-(07)-35 NP
- iii. Director of Treasuries shall make available copies of this order to the District / Sub Treasuries with digital signature of the Director of Treasuries through Treasury intranet
- iv. Treasury officers shall treat this order as an authorization letter, only when received with the digital signature of the Director of Treasuries, through Treasury intranet

- v. Implementing officers of the Local Governments shall also draw the amount by producing fully vouched contingent bills along with the allotment letter issued by the Secretary of the Local Government.
- vi. Treasury officer shall ensure that the contingent bills presented under SCP Fund by the Local Government should not exceed the authorization mentioned in the Government orders received through the intranet for this purpose.
