ORDER

As per Government Order read as 4th paper above sanction had been issued to release central share of Rs. 48,57,000/- and state share of Rs. 32,38,000/- being 2nd instalment (TSP Component) for implementation of NRLM/Aajeevika during 2016-17, based on the sanction order No. J-12023/01/2016-RL(NRLM-50C) dtd. 28.02.2017 generated from Ministry's website. But, Ministry of Rural Development has modified the 2nd instalment of central share (TSP component) as Rs. 35,17,000/- instead of Rs. 48,57,000/- in the above said sanction order subsequently.

2. Government of India in its letters read as 1st, 2nd and 3rd papers above have released an amount of Rs.83,75,000/- (Rupees Eighty three lakhs and Seventy five thousand only), as Central Share towards 2nd instalment under NRLM (General), Rs.48,57,000/- (Rupees Forty eight lakhs and Fifty seven thousand only) as central share towards 2nd instalment under NRLM(SCP) and Rs. 35,17,000/- (Rupees Thirty five lakhs and Seventeen thousand only) as Central share towards 2nd instalment under NRLM (TSP) for the year 2016-17. It is directed to release the amount along with corresponding state share to the Executive Director, Kudumbashree, Kerala. The funding pattern is 60:40 between centre and the state.

3. Government after having examined the matter are pleased to authorise the Commissioner, Rural Development Department to release an amount of **Rs. 2,79,15,000 /--** (Rupees Two Crore Seventy Nine Lakh and Fifteen Thousand only) to the Executive Director Kudumbashree, Kerala being the 2nd instalment of Central and State Share under National Rural Livelihoods Mission/Aajeevika for the year 2016-17 as detailed below:-
