**ORDER**

Government, in the order read 1<sup>st</sup> above, have accorded in-principle sanction to the Director of Treasuries for proposing the project of the construction of 36 Treasuries and renovation of 19 existing Treasury buildings for assistance from KIIFB and also to designate INKEL as the implementing agency of the project. As per the letter read 2<sup>nd</sup> above, the Director of Treasuries has submitted proposal for the construction of 10 Treasury buildings for an amount of Rs. 21,14,15,000/- in the first phase with the detailed project report from INKEL Ltd.

Government have examined the proposal in detail and are pleased to accord in-principle sanction for the construction of following 10 treasury buildings for an amount of Rs. 21,14,15,000/- (Rupees Twenty One Crore Fourteen Lakh and Fifteen Thousand only) with the financial assistance from the Kerala Infrastructure Investment Fund Board (KIIFB) and also to designate Infrastructure Kerala Ltd

(INKEL) as the special purpose vehicle (SPV) for the implementation of project.
