ORDER

As per G.O. read above, online bill system has been introduced for bills presented by all grant-in-aid institutions. As per the new system, the grantee institutions shall submit their claims to the countersigning authorities concerned and the Drawing and Disbursing Officers (DDOs) under them shall process the claim and submit the bill online to the treasury. Accordingly, the Under Secretary, Agriculture (Farms) Department and the Under Secretary, Agriculture (Animal Husbandry-F) Department have been declared as the Drawing and Disbursing Officers for processing the grant in aid bills under Kerala Agriculture University and Agriculture (Animal Husbandry) Department vide G.O. read 2nd and 3rd respectively. Now Agriculture (IFA) Department vide e-file read above has furnished the proposal for declaring the Deputy Secretary, Agriculture (IFA) Department as the Drawing and Disbursing Officer for processing the grant in aid bills under Agriculture (IFA) Department.

2. Two DDOs have already been declared in Agriculture Department for processing grant in aid bills. So declaring more DDOs for the purpose is not advisable in the IFMS scenario.

3. In the above circumstance, Government are pleased to declare the Under Secretary, Agriculture (Farms) Department as the Drawing and Disbursing Officer for processing the grant in aid bills of all the institutions under Agriculture Department. However the DDO already declared vide G.O. read 3rd above, shall process all grant-in-aid bills under Agriculture (Animal Husbandry) Department.

4. The G.O read 2nd above stands modified to this extent.
