### **ORDER**

—

Government of Kerala have earmarked an amount of ₹6227,50,00000/- as Expansion and Development Fund for the year 2017-18 to the Local Governments. Government in its order read as 2<sup>nd</sup> paper above have ordered to authorize Development Fund except the fund for KLGSDP with World Bank Assistance to be authorized to the Local Governments in three installments viz, March (to be spent from 1<sup>st</sup> April 2017), July and November (to be spent on or before 31<sup>st</sup> March of the Financial Year) of every year.

Government in its order read as 3<sup>rd</sup> paper above have modified the *inter se* distribution of funds for various components to the Local Governments. Considering the same, authorization for the 1<sup>st</sup> installment of the Development Fund except fund for

KLGS DP for the Financial Year 2017-18 is worked out as ₹2044,16,67,000/- (Rupees Two Thousand and Forty Four crore Sixteen lakh Sixty Seven thousand only). Based on the same the following orders are issued:

1. Authorization of 1<sup>st</sup> installment of Development Fund amounting to ₹2044,16,67,000/- (Rupees Two Thousand and Forty Four crore Sixteen lakh Sixty Seven thousand only) is issued to the Local Governments as in Annex I to V.
2. Director of Treasuries shall make available copies of this order to the District / Sub Treasuries with digital signature of the Director of Treasuries through Treasury intranet.
3. Treasury officers shall treat this order as an authorization letter, only when received with the digital signature of the Director of Treasuries, through Treasury intranet only.
4. The head of Account from which the amount is to be drawn for each tier of Local Governments is given in the Annexes.
5. Secretaries of Local Governments shall draw the amount from the revenue head of account '3604' by producing fully vouched contingent bills.
6. Implementing officers of the Local Governments shall also draw the amount from the revenue major head of account '3604' by producing fully vouched contingent bills along with the allotment letter issued by the Secretary of the Local Government.

7. Treasury officer shall ensure that the contingent bills presented under Development Fund from a Local Government should not exceed the authorization mentioned in the Government orders received through the intranet for this purpose.
