Government of India had released an amount of **Rs. 1,76,89,000/-**, **Rs. 1,02,59,000/-** and **Rs. 74,29,000/-** as 1st instalment of Grant-in aid under General, SCP and TSP components of NRLM respectively as per sanction orders read as 1st paper above. As per G.O. read as 2nd paper above Government of Kerala released the central share along with matching state share in the ratio 75:25. Subsequently, GoI have revised the funding pattern between Centre and state from 75:25 to 60:40 and this revised funding pattern is made applicable to all central share released from 1st April, 2015 vide letter read as 4th paper above. Now as per letter read as 5th paper above the Executive Director, Kudumbashree has requested to release the balance amount of state share of the 1st instalment of Grant-in-aid already released during the year 2015-16 as per the revised funding pattern.

2. Government after having examined the matter in detail, are pleased to authorise the Commissioner, Rural Development Department to release an amount of **Rs. 1,17,21,999/-** (Rupees One crore Seventeen Lakh Twenty one Thousand Nine hundred and ninety nine only) to the Executive Director, Kudumbashree, Kerala being the balance amount of state share of 1st instalment of NRLM/Aajeevika for the year 2015-16 as detailed below:-
