ORDER

The Secretary, Kerala Khadi and Village Industries Board (KK & VIB) vide letter read as 5th above has requested Government to revise the pension and other related benefits of retired employees of KKVIB in accordance with the Government Order read as 2nd above.

Government have examined the matter in detail and are pleased to sanction the benefits of revision of pension and other related benefits as per G.O read as 2nd above, to the retired employees of Kerala Khadi and Village Industries Board subject to the following conditions.

1. The committee constituted as per G.O read as 3rd above for

transforming of Kerala Khadi and Village Industries Board into Department should submit their report on or before 31.05.2017.

2. The Administrative Department should take final decision on the above report on or before 31.08.2017.
3. The Government will consider providing additional grant/financial assistance for the year 2017-2018, 2018-19 only after receiving the report of the committee.
4. If Kerala Khadi and Village Industries is not converted as a Department before 31.12.2017 the Government will consider providing grant for the financial year 2018-19 only after implementing the conditions as per G.O read as 1st above.
5. Administrative Department should ensure that the employees who got appointment after 01.04.2013 should come under National Pension System in the Kerala Khadi and Village Industries Board.
