ORDER

The Special Rules of Medical Officers in Indian Systems of Medicine Department has been framed vide G.O read as 1st above wherein, three posts, viz, Superintendent (Nature Cure), Senior Specialist(Nature Cure) and Medical Officer(Nature Cure) are included under Nature Cure Unit. As per G.O read as 2nd paper above orders were issued revising pay and allowances of State Government Employees and Teachers w.e.f 01.07.04 wherein the posts of Specialist(Nature Cure), Senior Specialist(Nature Cure) and Superintendent(Nature Cure) were included in the department schedule of ISM Department in tune with the Special Rules. But these posts except Medical Officer(Nature Cure) were not covered under the 9th Pay Revision Order issued vide G.O read as 3rd paper above for want of creation of posts under Nature Cure Unit. As per G.O read as 5th above

orders were issued revising pay and allowances of State Government employees & teachers w.e.f 01.07.14, wherein too only the post of Medical Officer(Nature Cure) with revised scale of pay Rs. 39500-83000 is included. The Director, ISM Department vide his letter read above has reported that posts of Superintendent (Nature Cure) & and Senior Specialist (Nature Cure) have been created in the department vide G.O read 4th paper above and so he has proposed to add the posts of Superintendent(Nature Cure) and Senior Specialist(Nature Cure) in the Pay Revision Order in the scales of pay of Rs.45800-89000 and 42500-87000 respectively at par with that of Chief Medical Officer and Senior Medical Officer in the Department.

2. Government have examined the matter in detail and are pleased to incorporate the posts of Superintendent (Nature Cure) and Senior Specialist (Nature Cure) with scales of pay of Rs.45800-89000 and 42500-87000 respectively in the department schedule of ISM Department at page No.233 of the G.O read as 5th paper above.
3. This order will take effect from 01.07.2014


