**ORDER**

As per the Government Order read as 2<sup>nd</sup> above, orders have been issued revising pay and allowances of State Government Employees and Teachers with effect from 01.07.2014, wherein the posts of Dietician in Health Services Department are available in three grades, ie, Gr.II, Gr.I and Senior Grade in the ratio 2:2:1. Eventhough these three grades of Dieticians are existing in Medical Education Department also, no ratio has been prescribed for these grades, without which ratio promotion to higher grades cannot be done. Prior to the abolition of the system of dual control of posts by the Director of Health Services and Director of Medical Education as per the G.O read as 1<sup>st</sup> paper above, the Dieticians in Medical Education Department were used to be granted ratio promotion to higher grades based on the ratio existed in the Health Service Department. This is no longer possible since both the departments now stand delinked in the control of posts. Therefore, the Director of Medical Education has reported,

in the letter read above, that he could not make promotions to the higher grades for want of ratio in the Pay Revision Order 2014 and has proposed to allow the ratio 2:2:1 among Dietician Grade II, Grade I and Senior Grade in the Medical Education Department also as existing in Health Services Department.

2. Government have examined the matter in detail and are pleased to order that the post of Dietician Gr.II, Gr.I and Senior Grade in Medical Education Department will be in the ratio of 2:2:1 w.e.f 01.02.2016.
