ORDER

As per Government Order read 2nd above, Government have issued orders revising Pay and Allowances of State Government employees, Staff of Educational Institutions and Part Time Contingent Employees w.e.f 01.07.2014 wherein Uniform Allowance at varying rates has been sanctioned to different categories of employees who are required to wear uniform during duty time. The Director of Health Services vide his letter read above has reported that the categories of L.D. Binder, U.D Binder, Plate Maker and Assistant Offset Machine Operator attached to the Family Welfare Offset Press under Health Services Department are required to wear uniform and were allowed Uniform Allowance prior to 10th pay revision invoking the special provision in the G.O read as 1st above that the categories which were not included in the schedule of

Uniform Allowance would be sanctioned Uniform Allowance @ Rs. 1600/- per annum. No such special provision is in existence in the 10th Pay Revision Order. He has, therefore, reported that now Uniform Allowance could not be sanctioned to these employees because the categories do not figure in the schedule of Uniform Allowance in the G.O read as 2nd above and has proposed to sanction Uniform Allowance to the categories of L.D. Binder, U.D, Binder, Plate maker, and Assistant Offset Machine Operator attached to the Family Welfare Offset Press under Health Services Department.

2. Government have examined the matter in detail and are pleased to sanction Uniform Allowances @ Rs.1800/- per annum to the categories of L.D Binder, U.D. Binder, Plate Maker and Assistant Offset Machine Operator attached to the Family Welfare Offset Press under Health Services Department.

3. This order will take effect from 01.04.2016.


