## **CIRCULAR**

Sub:- Pay Revision 2014 – Delinquency in Crediting Pay Revision Arrears to Provident Fund Account – Strict Instructionsissued-reg

Ref:- 1.G.O.(P) No.7/2016/Fin dated 20/01/2016 2.Circular No.46/2016/Fin dated 19.05.2016 3.GO(P) No.45/2017/Fin dated 09.04.2017

As per the Government Order read as 3rd paper above, it has been ordered, among other things, that the first instalment of Pay Revision arrears fell due for payment on 01.04.2017 and interest thereon will be credited to the Provident Fund account of the employees. It has come to the notice of the Government that many Drawing and Disbursing Officers have failed to credit the amount to the Provident Fund account of the employees even after a lapse of more than three months causing loss of interest to the employees on their deposits to the Provident Fund. This laxity on the part of the Drawing and Disbursing Officers duty warranting disciplinary action. amounts to dereliction of Therefore, all Drawing and Disbursing Officers who have not credited Pay Revision arrears to the Provident Fund account will take urgent steps to credit the arrears before 16.08.2017. Any Drawing and Disbursing Officer, who fails to implement the direction, will be proceeded against under appropriate discipline and appeal rules and the loss suffered by the employees will be recouped from him. The Controlling Officers of the Drawing and Disbursing Officers should report on the defaulters to the Government in the Finance Department before 31.08.2017.
