ORDER

As per the G.O read as 2nd above, orders have been issued revising pay and allowances of State Government Employees and Teachers w.e.f 01.07.2014 wherein Uniform Allowance at varying rates has been sanctioned to various categories of employees including officers in the enforcement wing of the Excise Department, who are required to perform official duties in Uniform. The Excise Commissioner has reported that the categories of Joint Excise Commissioner, Deputy Excise Commissioner, Assistant Excise Commissioner, Excise Circle Inspector, Excise Inspector, Assistant Excise Inspector had been sanctioned Uniform Allowance by the G.O read as 1st paper above at a rate higher than that sanctioned now under Pay Revision orders. Hence he has requested to revise the rate of Uniform Allowance to the above categories of excise officers taking into account the rates sanctioned by the G.O read as 1st paper above.

2. Government have examined the matter in detail and are pleased to modify the rate of Uniform Allowance granted to the following categories of Excise personnel as follows:

Category	Existing Rate	Modified Rate (per annum)
Joint Excise Commissioner	Nil	5250
Deputy Excise Commissioner	3000	5250
Assistant Excise Commissioner	3000	5250
Excise Circle Inspector	4000	5100
Excise Inspector	4000	5100
Assistant Excise Inspector	4000	5100

3 .This order will take effect from 01.04.2016.


