**ORDER**

As per the Government Order cited, Government servants have been permitted to contest the elections to the Kerala State Library Council, District Library Council and Taluk Library Council constituted under the Kerala Public Libraries Act, 1989. In the letter read as 2<sup>nd</sup> paper above, the Secretary, the Kerala State Library Council, Thiruvananthapuram has proposed to sanction Special Casual Leave to the Government servants elected to the Library Council in order to attend the council meetings.

2. Government have examined the matter in detail and are pleased to order that Special Casual Leave not exceeding 20 days will be sanctioned in a calendar year on the basis of the attendance certificate issued by the Presidents of the respective Councils to those Government employees and teachers who are elected members to the Taluk, District and State Library Councils for attending the respective council meetings.
