ORDER

As per G.O. read as first paper above Government have issued the list of accredited agencies with detailed guidelines for the execution of public works through accredited agencies.

2. As per reference, 2nd above Uralunkal Labour Contract Co-operative Society has requested to exempt them from competitive bidding and as per reference 3rd above M/s. SILK has requested to revise their work area to the extent that " Civil Works" which are part of the contract works where design and fabrication of steel structures is involved and to modify the G.O read above accordingly.

3. Government have examined the matter in detail and are pleased to modify the G.O. read above by incorporating the following along with the last sentence of para 3(2) and para 3(9).

"..... and general works entrusted to Labour Contract Co-operative Society having men on their roll and machinery in their own stock".
