**ORDER**

The Chairman, Kerala State Pollution Control Board vide letter read as 3<sup>rd</sup> above has requested Government to revise the pension and other related benefits of retired employees of Kerala State Pollution Control Board in accordance with the Government Order read as 2<sup>nd</sup> above.

2) Government have examined the matter in detail and are pleased to revise the pension and other related benefits to the retired employees of Kerala State Pollution Control Board as per G.O read 2<sup>nd</sup> above subject to the following conditions.

1. The expenditure should be met from sinking fund maintained by Kerala State Pollution Control Board

2. The Government will not provide any additional funds over the budget provisions.
3. Administrative Department should ensure that the employees who got appointment after 01.04.2013 should come under National Pension System in the Kerala State Pollution Control Board.
4. A detailed report should submit to Finance Department after 3 months of issuing pension revision order in r/o details of remaining amount in pension fund, the expenditure for pension per month, Audit report of Pension Fund.
