Pay Revision 2014 – Revised House Rent Allowance to State Government Employees working in New Delhi - clarification - orders issued.

ORDER

As per the Government Order read as 1st above, Government have issued orders revising Pay and Allowances of State Government Employees and Teachers w.e.f. 01.07.2014, wherein it was ordered that the State Government Employees working in New Delhi and other states will be eligible for House Rent Allowance at Government of India rate as applicable at those places. Also as per Government Order read 2nd above, it was further clarified that the State Government Employees working in New Delhi are eligible for the existing rate of House Rent Allowance last drawn on the basis of the pre-revised scale till the implementation of the 7th Central Pay Revision.

The Resident Commissioner vide letter read as 3rd above has sought clarification on the admissibility of revised House Rent Allowance to State Government Employees working in New Delhi at Government of India rates and also on the admissibility of House Rent Allowance at enhanced rates when Dearness Allowance crosses the limits prescribed by the Government of India based on the recommendation of the Seventh Central Pay Commission.

2) Government have examined the matter in detail and are pleased to order that the State Government Employees working in New Delhi will be eligible for House Rent Allowance @ 24% of Basic Pay w.e.f 01.07.2017 and the rate of House Rent Allowance will be revised to 27% of Basic Pay when Dearness Allowance of Central Government Employees crosses 25% and to 30% of Basic Pay when the Dearness Allowances crosses 50%.
