Pay Revision 2014 – Finance (Inspection - Technical Wing) Department - Modification of designation and sanctioning of special allowance - orders issued.

ORDER

As per the Government order read as 1st above, Government had re-designated the posts of Executive Engineer and Assistant Executive Engineer in Finance (Inspection- Technical Wing) Department as Technical Examiner and Assistant Technical Examiner respectively. As per the Government Order read as 2nd above, orders were issued revising the scale of pay and allowances of State Government Employees and Teachers w.e.f. 01.07.2014 wherein certain technical posts included in the Schedule of Posts held by personnel of other departments and Special Allowance (Annexure VIII) under Finance Secretariat are found to be different from the technical posts re-designated as per Government Order read 1st above. The post of Assistant Chief Technical Examiner was not included in the

schedule of Special Allowance (Annexure VIII) under Finance Department of the Government Order read 2nd above.

2. Government have examined the above matter in detail and are pleased to issue the following orders:

(i) The posts of Technical Officer, Executive Engineer, Assistant Executive Engineer, Assistant Engineer in the Schedule of Posts held by personnel of other departments under Finance Secretariat will be substituted with Technical Examiner (Civil, Electrical) and Assistant Technical Examiner (Civil, Electrical, Mechanical).

(ii) The posts of Executive Engineer/Technical Officer, Assistant Executive Engineer/Technical Assistant in the schedule of Special Allowance (Annexure VIII) under Finance Department in the 10th Pay Revision Order will be substituted with Technical Examiner (Civil, Electrical) and Assistant Technical Examiner (Civil, Electrical, Mechanical) respectively. The post of Assistant Engineer/Assistant Technical Officer in the schedule will be omitted.

(iii) The posts of Technical Examiner (Civil, Electrical) and Assistant Technical Examiner (Civil, Electrical, Mechanical) will be sanctioned Special Allowance at the existing rates of Rs.350/- and Rs.250/- per month respectively.

(iv)The post of Assistant Chief Technical Examiner will be included in the schedule of Special Allowance (Annexure VIII) under Finance Department and will be sanctioned Special Allowance @ Rs.400/- per month.

3. The date of effect of substitution and omission of posts will take effect from 01.07.2014 and Special Allowance from 01.02.2016.
