Dearness Relief on pension to Retired State Judicial Officers and Chairman and members of Kerala Public service Commission - who were in receipt of Dearness Relief at Central rates - with effect from 01.07.2008 - Revision - Orders Issued.

### ORDER

In the Government Order cited above, revised rate of Dearness Relief have been sanctioned with effect from 01.07.2008 to State Government Pensioners/Family Pensioners including those coming under UGC/AICTE/Medical Education Schemes. The Accountant General, Kerala in the letter read as 2nd paper above has informed that revision in Dearness Relief allowed to State Government Pensioners has not been extended to State Government pensioners / family pensioners drawing Dearness Relief at Central rates. This category includes retired judicial officers, Chairman and members of Kerala Public Service Commission.

(2) As per the Government Order cited 1st State Government has allowed 7% increase in Dearness Relief to all category of State pensioners where 50% merger in Dearness Relief was allowed. In the case of State Government Pensioners under UGC/AICTE they were in receipt of 47% Dearness Relief and after allowing 7% increase with effect from 01.07.2008 they are now getting Dearness Relief @ 54 %. State Government Pensioners / family pensioners drawing Dearness Relief at Central rates are also drawing Dearness Relief @ 47%, hence they are eligible for 7% Dearness Relief additionally from 01.07.2008.

(3) Government have examined the matter and are pleased to order that Pensioners/Family Pensioners drawing pension at Central rates viz retired State Judicial Officers, Chairman and members of Kerala Public Service Commission will be eligible for 54% Dearness Relief with effect from 01.07.2008.


