**ORDER**

As per the G.O read 1<sup>st</sup> above, sanction was accorded for opening a joint non-interest bearing Special Treasury Savings Bank Account in the designation of the Additional Director and Senior Finance Officer of Collegiate Education Directorate with District Treasury, Thiruvananthapuram with a validity upto 31.03.2016 and again extended the validity up to 31.3.2018 vide G.O read 2<sup>nd</sup> above, for implementation of e-governance in Collegiate Education Department. Now the Additional Director of Collegiate Education vide letter read above has reported that the e-governance programme has not been completed and hence requested to extend the validity of the TSB account.


Government have examined the matter in detail and are pleased to accord sanction to extend the validity of the non interest bearing Special Treasury Savings Bank Account in the designation of the Additional Director and Senior Finance Officer of Collegiate Education Directorate with District Treasury, Thiruvananthapuram upto 31.3.2019 on condition that no further extension will be allowed and the balance as on 31.3.2019 is to be refunded to government account.
