**ORDER**

1. In the Government Order read as 2nd paper above, read with G.O. 3rd read above, Government had accorded sanction for advance payments to Kerala Nirmiti Kendra, District Nirmiti Kendras COSTFORD, Thrissur and Ooralumkal Labour Co-operative Society and the Pinarayi Industrial Co-operative Society Limited No. 5 for taking up works under the SDF for MLAs, in partial modification of Government Order read as 1st paper above.

2. The Executive Director of the Socio Economic Unit Foundation, an accredited agency for execution of projects under Decentralized Planning, has requested Government to consider the Foundation also for receiving advance payment as applicable to other accredited agencies coming under the purview of Government Order read as 2nd paper above.

3. Government having considered the suggestion, are pleased to order that the Socio Economic Unit Foundation also will be eligible for receiving advance payments for the works taken up for implementation under the Special Development Fund for MLAs as per the same terms and conditions applicable to other accredited agencies, viz.:

- (a) Stage One : 20% of the total cost on execution of agreement.

- (b) Stage Two, : 20% each of the total cost on production of utilization three and four certificates with relevant documents showing expenditure of 90% of the advance at that stage.
- (c) Stage Five : 10% of the total cost on production of utilization certificate with relevant documents showing expenditure of 90% of the advance amount given at that stage.
- (d) : The final 10% shall be paid after getting the Completion Report from the Implementing Agencies in accordance with the codal provisions.

4. The District Collectors concerned shall make payments from the Special Treasury Saving Bank Account relating to SDF for MLAs after ascertaining from the agency that the work will be undertaken without delay. If the work cannot be started, for any reason, within a period of 3 months from the date of payment of advance, the District Collector shall take necessary steps to get the advance recovered back from the agency.

5. The Government Orders read as first, second and third papers above, will stand modified to this extent.
