ORDER

In partial modification of para 2.8 of the Government Order read above, Government are pleased to order that advance payment can be made to the Kerala State Nirmithi Kendra, District Nirmithi Kendras, COSTFORD, Thrissur and Ooralunkal Labour Co-operative Society for the works taken up for implementation by them under the Special Development Fund for MLAs, as follows:

- (a) Stage One : 20% of the total cost on execution of agreement.
- (b) Stage Two, Three & Four : 20% each of the total cost on production of Utilization Certificate with relevant documents showing expenditure of 90% of the advance at that stage.
- (c) Stage Five : 10% of the total cost on production of Utilization Certificate with relevant documents showing expenditure of 90% of the advance amount given at that stage.
- (d) The final 10% shall be paid after getting the Completion Report from the Implementing Agencies in accordance with the codal provisions.

2. The District Collectors concerned shall make the payment from their Special Treasury Saving Bank Account after ascertaining from these agencies that

the work will be undertaken without delay. If the work cannot be started for any reason, within a period of three months from the date of payment of advance, the District Collector concerned should take necessary steps to get the deposit back from these agencies.

3. The Government Order read above stands modified to this extent.
