**ORDER**

In the Note read above it has been pointed out that as per the Public Works Rules to Panchavats and Urban Local Governments, certain agencies have been accredited for implementing public works at estimate rates, without going through the tender process. The accredited agencies are:

- 1) Nirmithi Kendra,
- 2) Cost Ford, Thrissur
- 3) Ooralunkal Labour Co-operative Society
- 4) Pinarayi Industrial Co-operative society, and
- 5) Socio -Economic Unit Foundation (for water supply and sanitation)

Therefore, it has been suggested that these agencies may be permitted to execute works under SDF for MLAs also on the same conditions, if so decided by the District Collectors.

2. In the circumstances, Government order that works under the scheme Special Development Fund for MLAs can be entrusted to any of the above mentioned accredited agencies, if the District Collector so decides, without going through the tender procedures at the estimate rates based on the latest approved Schedule of Rates of the Public Works Department.

3. No provision for contractors profit shall be allowed in the estimate.

4. No cost escalation will be allowed on this

5. All other procedures for execution of work under the SDF for MLAs shall be followed
