Sub:- Availing Maternity Leave in different spell - clarification issued.

Ref:- G.O (P) No. 580/09/Fin dated 30/12/2009.

As per G.O cited it has been ordered that a female officer on Maternity Leave who get appointment in another Department / same Department by direct recruitment/ transfer/ promotion will be allowed to avail the balance portion of Maternity Leave from the next day of her joining duty in the new Post/ Department subject to the conditions therein.

Government have been receiving several requests to extend the above benefit to those who are transferred from one station to another within the same Department.

Government have examined the matter in detail and it is clarified that since no monetary loss is incurred by the officers in such transfer, the benefit of Government Order dated 30/12/2009 need not be extended to those who are transferred from one station to another. The transferee can be permitted to join duty in the new station after availing of the whole period of maternity leave admissible to her.
