ORDER

The time limit for crediting arrears of DA to the PF Account of the employees sanctioned as per GO read as 1st, 2nd, 3rd & 4th papers above, were extended vide GO read as 7th paper above and the extended time limit expired on 31st July 2011.

Several requests are being received from various Heads of Institutions and individuals seeking extension of time for crediting the arrears of DA to the PF account for the period from 01.01.2008 onwards.

Government have examined the requests and are pleased to order that the time limit for crediting the arrears of DA sanctioned from 01/01/2008, 01/07/2008, 01/01/2009, 01/07/2009, 01/01/2010 and 01/07/10 to the PF Account of employees will be extended for 6 months. The DA arrears can be claimed in the salary bill upto 29th February 2012 and credited to PF Account without fail. Further chance for crediting the arrears of Dearness Allowance sanctioned upto 01/07/2008 will not be allowed.

All controlling officers will adhere to the time schedule invariably.
