ORDER

As per Rule 53 (b) Part I, KSRs, an officer appointed to hold full additional charge of another post is entitled to draw Special Allowance at a rate not exceeding 7% of the minimum of the scale of pay of the additional post; if the appointment is to discharge current duties alone, the rate of special allowance admissible should not exceed 4% of the minimum of the scale of pay of the additional post.

Following implementation of 9th Pay Revision, Government have examined revision of rates of Special Allowance admissible for holding additional charge and are pleased to order that the existing special allowance @ 7% for full additional charge and @ 4% for discharge of current duties will be revised to 6% and 3% respectively with effect from the date of change over to the revised pay scale or with effect from 1.2.2011 whichever is later.
