“However, the employees who were promoted on or after 1.7.2009 can be allowed to opt the revised scale of the promotion post w.e.f. the date they had opted for fixation of pay under Rule 28 A, Part I, KSRs in the scale of pay of the promotion post as per option (b) under Rule 28 A, Part I, KSRs”.


