Consequent to the revision of pay and allowances of State Government employees, Teachers and University employees as per the Government Orders read as 1st and 2nd paper above, a large number of representations were received for rectification of anomalies in the Pay Revision Order. The representations submitted as per the directions contained in the Circular read above were examined in detail and necessary orders have been issued in respect of genuine anomalies detected. More than four years have passed since the implementation of the last Pay Revision and also Government have constituted the 10th Pay Revision Commission as per the Government Order read as 4th paper above. Still a number of representations from individuals, service organisations and Administrative Departments are being received in Finance Department seeking rectifications of anomalies in Pay Revision 2009. In these circumstances, it is hereby instructed that all the

pending requests for rectification of anomalies in Pay Revision 2009, if any, should be referred before the 10th Pay Revision Commission.
