### **ORDER**

As per Government Order read 1<sup>st</sup> above guidelines have been issued for realization of regular contribution in respect of deputation staff. The Director of Treasuries in the letter read above have suggested certain modification for the smooth implementation of the scheme.

Government after examining the matter are pleased to issue certain modification to the Government Order read 1<sup>st</sup> above .

The NPS contributions in respect of SDOs/AIS officers shall be remitted directly in the banking treasuries nearest to their offices by the same means.</p> <p>(ii) The parent DDO who receives the Demand Draft shall present it along with the necessary treasury chalan and the schedule (I) in the banking treasury attached with the particular office/nearest banking treasury as the case may be for remittance. The DDO of the subscribers who are drawing salary by way of cheques/Demand Draft etc., shall make payment of the</p>	<p>The Officer who is acting as DDO of the subscriber under deputation shall recover /deduct appropriate portion of the NPS contribution as envisaged in the circular cited from the salary of the subscriber and send it along with equal matching contribution by way of Demand Draft. Separate Demand Draft for employee and employer contribution shall be taken in favour of the DTO concerned which can be drawn at the bank associated with the DTO. For this, the District Treasury Officer shall obtain an additional DDO Registration Number.</p> <p>The Demand Draft shall be submitted to DTO along with schedule appended to this Order. A copy of the schedule may be furnished to the officer who is acting as DDO of the employee under deputation and one copy to DDO of parent department.</p>

	NPS contributions of the subscribers in his office by way of Demand Draft as detailed herein.	Separate chalan shall also be submitted along with Demand Draft specifying the head of account ordered in Para III of Government Order read 1 <sup>st</sup> above. The above modality shall be made applicable in the case of those who are working under certain schemes where the salary is disbursed through DD/Cheque.

With regard to Inter Sector Shifting of PRAN in respect of employees on deputation the DTO concerned will act as DDO and DTO for pursuing modalities in the regard. Employee shall prefer ISS I form along with supporting documents to the DTO, of the nearest District treasury.

In the case of employees deputed to State Government departments from autonomous bodies, Central Government and other State Governments the direction issued vide G.O read 2<sup>nd</sup> above shall be followed.
