### ORDER

1. Government of India vide letter read as 1<sup>st</sup> paper above has released an amount of Rs.20,00,00,000/- (Rs. 17.82 Crore as Grants in aid General, Rs.1.96 Crore as Grant in aid (SCP) and Rs. 0.22 Crore as Grant in aid (TSP) being the 1<sup>st</sup> instalment of Central assistance for the implementation of Integrated Watershed Management Programme (IWMP) Project under Watershed component of Pradhan Manthri Krishi Sinchayee Yogana (PMKSY).

2. As per the Government Order read as 2<sup>nd</sup> paper above Government accorded sanction for the release of central share of Rs.17.82 crore. But the debit was erroneously ordered to be made from the head of account 2515-00-102-53(02) instead of 2515-00-102-53(01).

3. Government, after examining the matter order that the head of account 2515-00-102-53(02) referred in the Government Order 2<sup>nd</sup> above will be corrected and read as 2515-00-102-53(01)
