ORDER

1. Government of India in its letter read as 1st paper above had released an amount of Rs.20,00,00,000/- (Rs. 17.82 Crore as Grants in aid General, Rs.1.96 Crore as Grant in aid (SCP) and Rs. 0.22 Crore as Grant in aid (TSP)) being the 1st instalment of Central assistance for the implementation of Integrated Watershed Management Programme (IWMP) Project under Watershed component of Pradhan Manthri Krishi Sinchayee Yogana (PMKSY) 2015-16. The Central release of Rs.17.82 Crore (Seventeen Crore Eighty Two Lakh only) and State release of Rs.11.88 Crore were transferred to the implementing agencies vide Government Order read as 2nd and 3rd papers above.

2. Sanction is hereby accorded to issue administrative sanction for the release of an amount of Rs. 3,63,33,334/- (Rupees Three Crore Sixty Three Lakh Thirty Three Thousand Three Hundred Thirty Four only) being the 1st instalment of Central and State Share under the Pradhan Manthri Krishi Sinchayee Yogana (PMKSY) 2015-16 as detailed below:-

3. The Commissioner, Rural Development (C R D), Thiruvananthapuram will arrange to draw and release funds received from Ministry of Rural Development, Government of India to the implementing agencies as per Government Order read as 5th paper above.

4. The Projects Directors, IWMP shall ensure that the fund released is utilized as per the conditions stipulated in the orders releasing funds by the Ministry of Rural Development, Government of India, read as 1st paper above.

5. This transfer of funds is exempted from all treasury restrictions.
