ORDER

The scale of pay of the post of Security Guard in Kerala Public Service Commission and in Government Secretariat were the same upto the 8th Pay Revision. But as per 9th Pay Revision Order read as 3rd paper above, the post of Security Guard in Kerala Public Service Commission was sanctioned the scale of pay of Rs.9190-15780 whereas a higher scale of pay Rs.9940-16580 was sanctioned to the post in Government Secretariat. Aggrieved by this, Sri. Rajeev Kumar.A, Security Guard, Kerala Public Service Commission filed OA No.2485/2014 before the Kerala Administrative Tribunal. In the order dated 01/10/2015 in the above OA, the Hon'ble Tribunal has directed the 1st Respondent i.e. Principal Secretary (Finance) to take a decision in Annexure A7 representation submitted by the applicant within a period of two months from the date of receipt of a copy of the order.

In compliance of the order dated 1/10/2015 of the Kerala Administrative Tribunal, the applicant was heard on 11/12/2015.

Government have examined the matter in detail and it has been found that the qualification and mode of appointment for the post of Security Guard in Kerala Public Service Commission and Government Secretariat were unified as per the Government Order read as 1st paper above. The applicant was appointed from a common ranked list prepared for appointment to Government Secretariat and Kerala Public Service

Commission vide Gazette Notification read as 2nd paper above before the issuance of Pay Revision Order 2009, in which the scale of pay mentioned for the post was 5250-8390(pre-revised). As per the existing order, the recruitment rules of the post of Security Guard in the above two departments are the same and the appointment to the two departments are made from a common ranked list. But the candidates appointed to Kerala Public Service Commission from the above ranked list are drawing the scale of pay of Rs.9190-15780, while those appointed to Secretariat are drawing Rs.9940-16580, consequent to Pay Revision 2009.

Government are therefore pleased to modify the scale of pay of the post of Security Guard in Kerala Public Service Commission as Rs.9940-16580 w.e.f.1/7/2009, equal to that of the similar category in Government Secretariat. The Department schedule of Kerala Public Service Commission appearing at page 204 of the Government Order read as 3rd paper above will stand modified to this extent.

The order dated 1/10/2015 of the KAT in OA No. 2485/14 is complied with accordingly.
