CIRCULAR

Sub:- Finance (Inspection Wing -Technical) Department - Submission of reports to the Chief Technical Examiner - Instructions issued - Reg.

Ref:- G.O.(Rt) No.590/15/Fin dated 28.12.2015.

As per Government order cited above, work intimation reports to the Chief Technical Examiner for conducting the inspections in Public Works shall be done through Technical Inspection Monitoring System (TIMS) Software with effect from one month on implementation of the Software.

Now, during a discussion with the Director, National Informatics Centre, it was informed that a few months time is required for the implementation of (TIMS) Software owing to Security Audit and other technical reasons.

In view of the aforesaid delay in implementation of the (TIMS) Software and for identifying the Nodal officers for Quality Control Wing in all agencies taking up public works, following further instructions are issued:-

1. Work intimation Reports as stipulated in the Government Order cited above shall be submitted to the Chief Technical Examiner through Registered post / Speed Post of "India Post" with acknowledgement due only, till the TIMS Software is launched.

2. All reporting shall be done at least 7 working days before the proposed date of commencement of the items till implementation of TIMS Software.

3. The reporting to the Quality Control Wing shall be done only after getting instructions from this Wing. Till then, all reporting shall be addressed to the Chief Technical Examiner only.

4. All Kerala Government Engineering Departments / PSUs / Statutory bodies / Universities / Joint Venture Organisations / Autonomous bodies of Government of Kerala and enlisted agencies taking up public works of Government shall intimate the details of the "Nodal Officers" of the Quality Control Wing (Executive Engineer) identified for receiving the reports and initiating inspections in each Districts by 08.03.2016 so as to issue a separate Government Order for authorising the Nodal officers to submit the reports to this Wing.

5. The reporting as per this circular shall commence from 08 Mar 2016 , till the TIMS software is launched.


