### ORDER

Government of India in its letter read as 1<sup>st</sup> and 2<sup>nd</sup> papers above, have released an amount of **Rs.64,89,15,600/-** (Rupees Sixty Four Crore Eighty Nine Lakh Fifteen Thousand and Six Hundred only) and **Rs.51,57,73,900/-** (Rupees Fifty One Crore Fifty Seven Lakh Seventy Three Thousand and Nine Hundred Only) to the State Government of Kerala as second instalment (including administrative cost) of Central assistance under General Sector and Tribal Area sub plan for implementing of Indira Awaas Yojana for the year 2015-16 in various districts of the state (except Wayanad). The funding pattern for the General Sector and TSP is 60:40 between the centre and the state. The above funds have to be released to the Accounts maintained for this purpose by the Project Director, Poverty Alleviation Unit of various districts (except Wayanad).

2.Government after having examined the matter in detail, are pleased to accord administrative sanction for the release of an amount of **Rs. 116,46,89,500/-**(Rupees One Hundred and Sixteen Crore Forty Six Lakh Eighty Nine Thousand and Five Hundred Only) being the 2<sup>nd</sup> instalment of Central Share under Indira Awaas Yojana for the year 2015-16 as detailed below:-

3. The Commissioner, Rural Development Department will draw and release funds from the Ministry of Rural Development, Government of India to the implementing agencies as per G.O read as 3<sup>rd</sup> paper above.

4. The Project Directors, PAUs shall ensure that the fund released is registered in the Public Financial Management System (PFMS) and the conditions stipulated in the orders releasing funds by the Ministry of Rural Development, Government of India, read as 1<sup>st</sup> and 2<sup>nd</sup> papers above are strictly complied with.

5. This transfer of fund is exempted from all the existing treasury restrictions.
