### ABSTRACT

### ORDER

Government of India in its letter read above have released an amount of **Rs.1,93,28,000/-** (Rupees One Crore Ninety Three Lakh Twenty Eight Thousand only) to the state Government of Kerala as additional funds of Central assistance for implementation of DRDA Administration scheme during 2015-16. The funding pattern is 60:40 between the centre and the state. Accordingly the amount have to be released to CEO, Zilla Panchayat/Project Director, DRDA which is the State level implementing agency.

2. Government after having examined the matter in detail, are pleased to accord administrative sanction for the release of an amount of **1,93,28,000/-** (Rupees One Crore Ninety Three Lakh Twenty Eight Thousand only) being the additional funds of Central Share for the implementation of DRDA Administration Scheme as detailed below:-
