### ORDER

Government in its order read as 1<sup>st</sup> paper above have issued directions for transfer crediting the fund under SCP, TSP, KLGSDP and FC to General Sector under Development fund. Based on the report received from the Director of Treasuries on transfer credit, Government have issued GOs read as 2<sup>nd</sup> and 3<sup>rd</sup> papers above authorizing funds under KLGSDP and FC to the Grama Panchayaths, Municipalities and Municipal Corporations (FC only). It has come to the notice of Government that, in certain cases the funds already authorized have to be modified. The requests received from different quarters on this account were referred to the Director of Treasuries and she has submitted a report detailing the modifications to be effected.

Government after having examined the matter in detail, are pleased to issue the modified authorization of KLGSDP and FC funds as detailed in column 5 to the annexes 1 to 3 to this GO to the Local Governments referred to therein. The authorization issued in GO read as 2<sup>nd</sup> and 3<sup>rd</sup> papers above for those Local Governments mentioned in the annexes 1 to 3 stands cancelled.


