ORDER

Government of India in its letter read as 1st and 2nd papers above have released an amount of Rs.1,01,02,25,100/- (General Sector - Rs.54,30,06,500/-, SCP - 29,91,15,100/- and TSP Rs.16,81,03,500/-) to the State Government of Kerala as 1st Installment of IAY for the year 2015-16 in various districts of the State. The funding pattern was 50:50 between Centre and State. Government of India in its letter read as 3rd and 4th papers above have released an amount of Rs.116,46,89,500/- to the State Government of Kerala as second instalment (including administrative cost) of Central assistance under General sector and Tribal area sub plan for implementing of IAY for the year 2015-16 in various districts of the State (except Wayanad). Vide Government Order read as 5th, 6th and 7th papers above government had released the Central share along with State share to the implementing agencies at the ratio of 50:50. Now vide letter at 9th paper above, the Commissioner for Rural Development has informed that the funding pattern has been changed for the General Sector and TSP is 60:40 between

the Centre and State and requested to release the State share of 2nd installment as follows:

2. Government after having examined the matter in detail, are pleased to accord Administrative Sanction for the release of Rs.43,97,17,967/- (Rupees Forty Three Crore Ninety Seven Lakh Seventeen Thousand Nine Hundred and Sixty Seven only) being the corresponding State share in the pattern 60:40 under IAY for the 2nd instalment of the financial year 2015-16 as detailed below:-
