### ABSTRACT

### ORDER

Government of India in its letter read as 1<sup>st</sup> paper above have released an amount of **Rs.2,64,64,000/-** (Rupees Two Crore Sixty Four Lakh Sixty Four Thousand only) to the state Government of Kerala, as second instalment of Central assistance for implementation of DRDA Administration scheme, during 2015-16. The funding pattern is 60:40 between the centre and the state. Vide G.O.read as 2nd paper above Government had released the Central Share to the implementing agency.

2. Government are now pleased to accord Administrative Sanction for the release of an amount of **Rs. 1,76,42,667/-** (Rupees One Crore Seventy Six Lakh Forty Two Thousand Six Hundred and Sixty Seven only) being the second instalment of corresponding state share in the pattern of 60:40 for the implementation of DRDA Administration Schemes as detailed below:-
